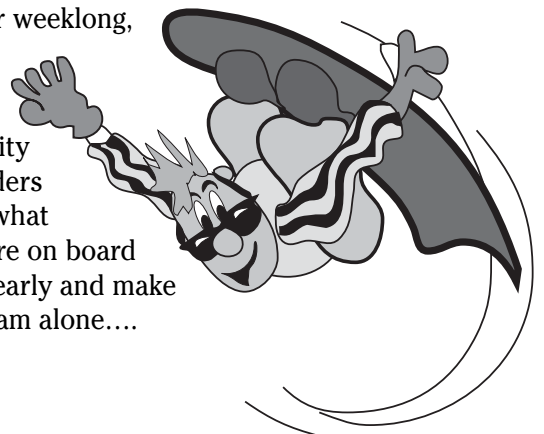

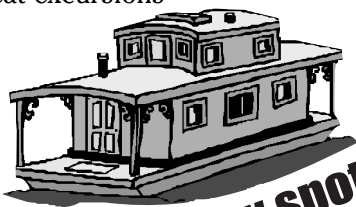

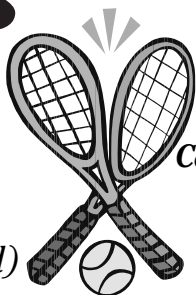

A Honky Tonk Week-end

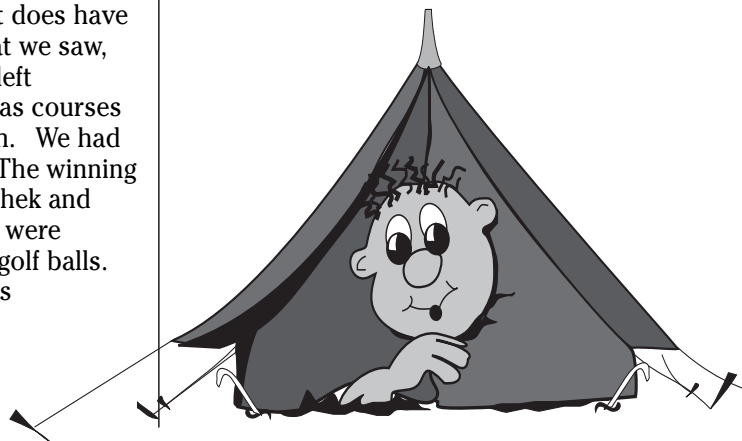
